Housing Benefit certification work for North Somerset Council for year ended 31 March 2016

We certified the Housing Benefit return, for the financial year 2015/16 relating to expenditure of £64.1 million on 24 November 2016. Further details of the claim certified are set out in Appendix A.

This certification represents a final but important part of the process to confirm the Council's entitlement to funding.

Whilst we are satisfied that the Council has appropriate arrangements to compile a complete, accurate and timely return for audit certification, there were issues arising from our certification work which we wish to highlight for your attention and which are set out below.

Issues arising

When undertaking our testing of non-HRA rent rebates, we identified one case where the Council had underpaid benefit due to an incorrect assessment of eligible rent.

When undertaking our testing of rent allowances, we identified one case where the Council had underpaid benefit due to an incorrect assessment of earned income.

In both of these cases, as there is no eligibility to subsidy for benefit that has not been paid, the underpayment did not affect subsidy and therefore has not been classified as an error for subsidy purposes.

The indicative scale fee set by Public Sector Audit Appointments for the Council for 2015/16 was \pounds 13,962. We are not varying from the indicative fee. This is set out in more detail in Appendix B.
