RECOMMENDATIONS

That the panel:

- 1. receives and considers the findings of the review of appointment arrangements to North Somerset Council Outside Bodies, and;
- 2. considers and agrees recommendations to the Executive Member portfolio holder accordingly.

1. SUMMARY OF REPORT

This report provides the findings and recommendations following a review of the North Somerset Council arrangements for appointments on outside bodies.

2. POLICY

The Corporate Plan sets out the vision for North Somerset as: a great place to live where people communities and businesses flourish, and for the organisation to provide: modern, efficient services and a strong voice for North Somerset.

The Constitution provides that appointments to external organisations are reserved to Council, save where such appointments have been delegated by the Council, or are exercisable by the Executive. Appointments of three or more are subject to political balance.

3. DETAILS

The Chairman of the Community and Corporate Organisation Policy and Scrutiny Panel was requested by the Leader of North Somerset Council to undertake a review of the current arrangements for the appointments to bodies to which the Council is required to appoint members, bodies where it is desirable for a member to be appointed, and those where the Council has a power of appointment but does not need to be a member.

It was considered that a review of the arrangements for these appointments was a timely undertaking. The remit for this review was restricted to consideration of the merit of each of the appointments, and did not extend to identifying individual appointment representatives.

Appointments made by Council are attached as Appendix 1, whilst the Executive appointments are attached as Appendix 2. Information provided in the recommendations in the appendices is based on the responses provided by those councillors currently holding the relevant appointment position.

The attached schedules of appointments list the name of the organisation, the current North Somerset Council representatives, recommendations posed and a summary of the recommendation to be considered by the Panel (see column 4 on the attached appendices). Recommendations regarding 'no change' are listed in white. Those indicating a proposed change are highlighted in yellow, and those recommended for removal are shown in red.

4. **CONSULTATION**

A small working party of Councillors consulted with both the organisations and the North Somerset Council representatives regarding each of the appointments in question.

5. FINANCIAL IMPLICATIONS

The Council has determined either that travel expenses to the main meeting place will be paid by the Council, with other travel expenses requiring prior authorisation or that expenses aren't paid by the Council, in which circumstances claims are submitted to the Outside Body concerned.

The Constitution provides that appointments to external organisations are reserved to Council, save where such appointments have been delegated by the Council, or are exercisable by the Executive. Political Balance applies to appointments of three or more.
