# 1. SUMMARY OF REPORT

The attached report supports Elected Members in their role overseeing the effectiveness of local health protection arrangements. It provides a summary of activity reported to the North Somerset Health Protection Assurance Group (HPAG), an update on progress against priorities set during 2018-19 and identifies seven priority work areas for 2019-20.

HPAG considers good progress was made overall against the 2018-19 priorities and is assured that local organisations have appropriate plans in place to protect the population. A small number of risks were identified throughout the year with appropriate mitigation put in place. These are described in the report.

The report is made up of two sections:

# 2. POLICY

The North Somerset Health Protection Assurance Group (HPAG) was established in September 2013. The HPAG provides a mechanism to assure the People and Communities Board, the Health Overview and Scrutiny Panel and the Director of Public Health that there are safe, effective and well-tested plans in place and appropriate activity is being delivered to protect the health of the population.

#### 3. **DETAILS**

The scope of the Health Protection Assurance Group is:

- emergency planning
- environmental health and communicable disease control
- screening and immunisation programmes
- effective management of sexually transmitted infections (STIs) and blood borne viruses
- infection prevention and control

The report provides a multi-agency overview of health protection activity. Key contributors include: Public Health (People and Communities Directorate); Environmental Health (Development & Environment Directorate); Community Safety and Drug Action (Corporate Services Directorate); Emergency Management Unit (Corporate Services Directorate); the Clinical Commissioning Group, Public Health England; NHS England Area Team and the Local Health Resilience Partnership.

#### 4. CONSULTATION

This report has been considered by the Health Protection Assurance Group and the Corporate Management Team. It will be shared with the Health Overview and Scrutiny Panel.

# 6. LEGAL POWERS AND IMPLICATIONS

This report provides assurance that there are safe, effective and well-tested plans in place and appropriate activity delivered to protect the health of the local population as required by legislation including the Civil Contingencies Act (2004), the NHS Act (2006) and the Health and Social Care Act (2012).

# 7. CLIMATE CHANGE AND ENVIRONMENTAL IMPLICATIONS

Severe weather events and flooding impact on the environment and are increasing in severity and frequency. This impacts on local health protection response arrangements and resources, the local NSC Climate Change Plan should help mitigate some of these pressures.

#### 8. RISK MANAGEMENT

The HPAG monitor specialist health protection areas through a risk register that is reviewed and updated with control measures. Risks identified for 2018-19 have been mitigated where possible. They can be summarised as:

- Robust local tested plans to respond and support Communicable Disease Control the plan is due to be updated and finalised by the end of March 2020.
- Childhood Immunisation rates measles mumps rubella MMR- locally rates remain higher than the England average but are under the 95% uptake target and will continue to be monitored.
- Flu vaccination rates improved performance across several target population groups
- Infection prevention and control in care homes training provided, and ongoing needs being addressed
