PAR Planning Application No.19/P/2443/FUH Retrospective application to retain front and rear dormer extensions at 14 Denny View, Portishead (Agenda item 6)

The Director of Development & Environment reported on an application for planning permission.

Notwithstanding the officers' recommendation to refuse permission Members considered that despite the built dormers exceeding the ridge height of the bungalow the overall effect wasn't overly dominant and was neither detrimental to the character of the dwelling nor did it have an adverse impact on the wider street scene, concluding that the development was acceptable and therefore Enforcement Action to remedy the breach of planning control was not required.

Resolved: that the application be **approved** on the basis that the development was not contrary to policies DM32 an DM38 or the Residential Design Guide Section 2 SPD.
