PAR Planning Application No. 20/P/0701/FUL Erection of 4no. buildings: 1no. building to be for Use Class B8 (Storage and Distribution) and 3no. buildings Puxton Park, Cowslip Lane, Hewish, Weston-super-Mare, BS24 6AH (Agenda Item 6)

The Director of the Place Directorate's representative advised members that there was no written update sheet and that the officer's report drew members' attention to the suitability of the site for the proposals.

Members considered that the proposed development would comply with policies DM69, CS22 and CS33, the site is accessible, and the proposals would serve the local community, provide an economic benefit and would not adversely affect the character of the area. They considered that the development would be compatible with the Puxton Park attraction and provide improved facilities and jobs and was acceptable subject to suitable conditions.

As such it was **resolved**: that contrary to the officers' recommendation, the application be **APPROVED** subject to conditions addressing the following matters the detailed wording of which is to be agreed with the Chairman, Vice Chairman and ward councillors as follows:
