1. Petition from Cllr Keating

Petition on changes to the A368 in Churchill

Banwell bypass is expected to be built during the next few years and this will significantly increase the amount of traffic using the A368 between Banwell and Churchill traffic lights.

The Dinghurst Road (A368) between the Churchill Parish Boundary, at Pye Cottage, and the traffic lights (A38) is already dangerous in many parts. When walking along the road pedestrians feel vulnerable and anxious about leaving their homes to walk to the shop or see friends. The signatures below indicate support for changes to be made to the road in Churchill before the opening of the Banwell bypass.

There are several suggestions for consideration and these are shown.

SPEED is the most important concern. The 30 mph originally started at the Parish boundary at Pye Cottage and extended to the lights. This was changed about 10 years ago with the 40mph was extended to 10 yards before the bottom of The Drive. The slower speed limit of 30 mph should revert to its original place at the Parish Boundary and consideration should also be given to it reducing to 20mph in line with proposals being considered by other villages along the line of route.

Lack of adequate pavements along the road are also a concern. From the lights to the Clock Tower is a very busy route for children of the village who go to Churchill Academy. This is a very narrow pavement and is heavily used at peak times. There have been incidents of pedestrians being brushed by the wing mirrors of vans. Between the Clock Tower and the Parish boundary at Pye Cottage it is very narrow in places which, in the main, can be helpful in slowing down traffic. There are a few places, however, where a pavement could be considered without it reducing the width of the road.

Those signing below are requesting that ***alterations be made to the A368 in Churchill to make it a safer road for residents and pedestrians.***
