The main issues that were identified by the Planning Inspector were whether the location, land use and amount of development would be acceptable with specific regard to: 1) whether it would be inappropriate development in the Green Belt; 2) its effect on the openness of the Green Belt; 3) access to services; 4) the character and appearance of the area; and 5) whether the harm by reason of inappropriateness, and any other harm, would be clearly outweighed by other considerations. If so, whether these would amount to the very special circumstances necessary to justify the proposal.

Councils' application for costs refused.

### Site: Land off Butts Batch, Wrington

Description: Outline planning application for access with all other matters reserved for the erection of up to 61 no. dwellings, including 18 no. affordable housing units (30%), along with access from Butts Batch, the provision of play facilities and public open space/ecological mitigation land, with associated works
